2023-24 ANNUAL REPORT

The mission of SIU Carbondale Head Start is to provide comprehensive school readiness and high-quality services for income eligible families with pre-school age children.

The Year in Review Dr. Lea Maue, Executive Director

SIU Carbondale Head Start is pleased to provide this required annual report (Head Start Act, 2007), which is a snapshot of program information and performance occurring July 1, 2023 through June 30, 2024. The 2023-24 program year was the fourth year in the five-year grant cycle. The program provided center-based services to children at its four locations, but due to teacher shortages, four classrooms were not open for the entire year, which significantly impacted enrollment. Although funded to serve 337 children and their families, the program enrolled no more than 290 at any single time and 328 cumulatively in the 2024-25 school year This is 42% of the income-eligible children in the service area (per most recent IECAM income demographic data) and a 6% increase from the previous program year. The program applied for an enrollment reduction at the end of the program year to serve 290 children with additional support in the classroom. This reduction was approved for the 2024-25 school year.

Despite enrolling less children this program year, the program was able to support 37 children with a documented disability receive services, far exceeding the federal requirement of 10% of cumulative enrollment. Additionally, the program transitioned 161 children to kindergarten, of which 86-96% met or exceeded developmental expectations (depending on area measured). Child outcomes indicate that children increased skills in almost all learning domains, demonstrating the program's commitment to school readiness and child success.

A federal onsite Focus Area Two (FA2) monitoring review occurred April 15, 2024 through April 19, 2024. The FA2 allows grantees to demonstrate effectiveness in implementing a high-quality program to promote positive outcomes and school readiness for children and their families. The review assesses a grantee's performance and to determines if programs are meeting the requirements of the Head Start Program Performance Standards. The review determined that the program was fully compliant with federal regulations with no areas of concern.



The following graph captures the number of children enrolled, including vacancies of less than 30 days and spots being held for foster or homeless children.














Financial Audit




SCHOOL READINESS

Preparing children for academic and social success in kindergarten and beyond is central to Head Start services. Every employee of Head Start plays a role in preparing children and families for success in school. The program continues to use Creative Curriculum 6th Edition to implement developmentally appropriate activities to children in the classroom. The program uses MyTeachingStrategies to document student progress and school readiness outcomes. Each child's school readiness outcomes are assessed three times per year. Outcomes are used to coach education staff to enhance school readiness in the classroom and plan for program training opportunities. 
School Readiness Outcomes: Social and Emotional Development








Partcipates Cooperatively and Constructively in Group Situations




School Readiness Outcomes: Physical Development

Fine Motor Strength and Coordination












School Readiness Outcomes: Approaches to Learning




School Readiness Outcomes: Cognition







Three-Year Old Children Meeting or Exceeding Developmental Expectations: 2024-25




Four-Year Old Children Meeting or Exceeding Developmental Expectations: 2023-24




CLASS Observations

Teachers are observed semi-annually using the CLASS tool by a CLASS observer certified. All Education Managers and Center Directors are certified. The CLASS tool assesses quality of classroom interactions across three domains – emotional support, classroom organization, and instructional support. Data indicates that the program is progressing towards its benchmark of a program average of 6 in emotional support, 6 in classroom organization, and 3 in instructional support.



Coaching

The program executed its coordinated practice based coaching plan which includes a tiered system of coaching and support ranging from direct to indirect to intensive coaching for child development staff. Intensive coaching is reserved for staff new to their positions or for those who have been identified as needing or wanting this level of coaching.



HEALTH AND NUTRITION


Meeting the health and nutrition needs of Head Start children and families is one primary concern for SIU Carbondale. The program provides comprehensive health services such as preventative vision and hearing screenings, height and weight monitoring, and fluoride varnish. We work closely with families to connect them with medical and dental services in the community. The program participates in the Child and Adult Food Care Program (CACFP) to provide nutritious meals and snacks to children.



Ready-For-School Screening and Resource Fair

SIU Carbondale started the 2023-2024 school year with a Ready-For-School Screening and Resource Fair (Intake Days) for all newly enrolled children in Jackson and Williamson Counties. Children received hearing and vision and height and weight screenings. Other services included a physical exam from the health consultant, who is a medical professional. Families received learning resources and other materials.

Dental Exams

Head Start Program Performance Standards require every child enrolled in our program to receive a Dental Exam [1302.24(b)(1)(i)]. SIU Head Start has the unique opportunity to partner with the SIU Dental Hygiene Program to ensure that this requirement is met. The SIU Dental Hygiene Program is the only Baccalaureate Dental Hygiene program in the state of Illinois and one of the premier programs in the country. SIU Dental Hygiene students and the Dentist and Dental Hygiene faculty perform dental exams. SIU Dental performed exams for 105 of 278 (37.7%) enrolled children.


FAMILY AND COMMUNITY PARTNERSHIPS



SIU Carbondale Head Start recognizes that parents are the first and most important teachers for their children. The program makes intentional efforts to support families through our family engagement approach to become active partners in the success of the educational development of their children. Families participate in activities throughout the program year including opportunities to become directly involved in the decision-making process of the program.

During the 23-24 program year, our Head Start engaged families in multiple ways: In-take Resource Fairs, Monthly Parent Meetings, Family Fall Fest, Literacy Night Activities, Family Engagement Months (October/February), 100 Days of Head Start Celebration/T-Shirt Day, and Kindergarten Transition events. Community Outreach Workers met with individual families at least monthly.

We continued our practice of family conferences, embracing the holistic approach of sharing information about children as well as family support services and resources. SIU Carbondale Head Start is committed to engaging and collaborating with families in respectful and empowering ways. Culturally responsive and systematic data driven practices guide program planning. Parents are encouraged and supported to become directly involved in decision making of the program by becoming active members of the Policy Council, IHSA Parent Leader/Parent Board Representative, Health and Family Services Advisory Committee, Male Advisory Panel, and as elected officers of the Parent Committee.
